SkiStar conducts all processing of personal data in accordance with the EU's data protection legislation GDPR. SkiStar AB is the data controller for the processing of the personal data we collect from you. SkiStar Norge AS, org.nr NO 977 107 520 MVA, is part of the SkiStar Group and processes your data when you are in contact with one of our Norwegian destinations. SkiStar AB and SkiStar AS therefore have joint personal data responsibility for certain data we collect about you when you are in contact with a Norwegian destination, but SkiStar AB has overall responsibility for the entire group's operations and exercises a dominant influence over the group companies. SkiStar AB is your main contact, and it is to us that you turn for questions and to exercise your rights. However, what is stated in this information document applies to all companies within the SkiStar Group.

1 PERSONAL DATA THAT MAY BE PROCESSED WHEN YOU INTERACT WITH US AS A LODGER OR SHAREHOLDER

When SkiStar processes personal data about you as a lodging or condominium owner, this is done primarily to be able to manage the contractual relationship between us (for example, to communicate with you about your property, pay compensation, manage owner accounts, etc.), but also to be able to fulfil legal requirements, such as being able to submit control information to the Swedish Tax Agency. SkiStar may collect and process personal data about you in our business relationship, directly with you or when entering and maintaining agreements.

Below is a description of the personal data we may process when you interact with us. We have categorised the personal data into specific categories of personal data to make it easy for you to get an overview of what data we may process and when. In the following sections, we describe for what we use these categories of personal data.

Bank details (e.g. bank, credit/debit card details, account number).

Booking details (as owner booking) (e.g. guest information, fellow travellers, booking number, length of trip, destination, what products/activities you booked).

Comments/references/evaluation (e.g. related to inspection/control/comment e.g. related to object, owner in the form of person/company)

Company details (e.g. company name, personal/contact information)

Contact details (e.g. e-mail address, postal/delivery address, telephone number)

Financial information (e.g. payment method, billing information, income, financial situation, shareholding)

Identity data (e.g. name, customer number, social security number (used in specific cases and printed separately), date of birth, gender, nationality).

Information on partners (e.g. Identity details, Contact details)

Information provided by the lodging/unit owner (e.g. answers to customer surveys, information in e-mail correspondence, chat, telephone)

Purchase details (e.g. product/service details in the context of rental)

Registration number (vehicle)

Specific information on the accommodation (owner, address, shareholding, housing association, property extract, etc.)

System authorisations (e.g. access rights, user credentials)

2 WHAT THE PERSONAL DATA IS USED FOR AND ON WHAT LEGAL BASIS

When you interact with us as a lodger/shareholder, we process your personal data. The personal data we process depends on the way you and any co-owners interact with us. We primarily process your and co-owners' data to fulfil the agreement with you and provide you with good service, but personal data may also be processed at an overall level for general market/customer analyses and statistics. We do this to constantly improve our products and services and to be able to deliver a memorable mountain experience. In the table below, you can read about 1) the purpose for which we use your personal data, 2) the types of personal data (personal data categories) we may use for each purpose and whether we have received the data from you or another source, and 3) the legal basis on which we use your data. 3 WHO MAY WE SHARE YOUR PERSONAL DATA WITH?

Your personal data will be transferred or shared with SkiStar's central accounting functions and to some extent the IT function. For the stated purposes, your personal data may also be disclosed to authorities or to system and service providers, partners, subcontractors such as cleaning and property management companies and insurance companies and auditors. If SkiStar sells or buys operations or assets, SkiStar may also disclose your personal data to a potential seller or buyer of such operations or assets.

4 HOW LONG WE KEEP YOUR PERSONAL DATA

Personal data collected and processed for us to fulfil our contract with you is processed throughout the term of the contract and stored for a further 10 years after the contractual relationship has ended. The data is stored primarily with regard to rules on limitation and also to be able to fulfil legal obligations, such as the Accounting Act, the Annual Accounts Act and tax legislation. In the event of a complaint and dispute, we save the information for up to ten years to be able to safeguard our interests in legal claims. Certain data, such as names, contact details and similar, may also be processed for up to two years after the end of the contractual relationship, for SkiStar to be able to contact the accommodation/shareholder for potential future business. Data stored based on our legitimate interest is stored based on internally developed storage decisions and varies depending on the processing.

5 YOUR RIGHTS

Right to information. You have the right to be informed about how we process your personal data. We do this through this policy and by answering any questions you may have.

Right to access your personal data. You have the right to receive a copy of the personal data we hold about you, as well as information about how we process it, by means of a so-called 'extract from the register'. If we receive a request for an extract, we may ask for additional information to ensure that we disclose the data to the right person. A copy is free to request.

Right to object. You always have the right to object to processing conducted based on our legitimate interest under the GDPR. In this case, we will balance the interests based on your specific situation to assess whether there is still a legitimate reason for us to process your personal data for the stated purpose.

Right to data portability. For automated processing carried out on the basis of consent or contract where the personal data was collected directly from you, you have a right to data portability, which means that you have a right to request your personal data in a structured, commonly used and machine-readable format.

Right to rectification, erasure, or restriction. You have the right to request that your data be deleted, completed, or rectified. If you believe that information about you is inaccurate or incomplete, you have the right to request that it be corrected or completed. You also have the right to request that the processing of your personal data be restricted in certain cases, for example while we rectify it. If you wish to have your data erased, you can contact us at personuppgift@skistar.com. If we receive a request for erasure, we may ask for additional information to ensure that you are you. However, please note that if we still have a legitimate reason to keep your data, for example under law or contract, your request may be rejected in whole or in part.

Right to lodge a complaint with the supervisory authority. If you believe that we are processing your personal data incorrectly, you have the right to lodge a complaint with the Data Protection Authority. Read more on the [website of the Data Protection Authority](#).
